- Applicants:** Original Artists and Crafters
- Space:** A 12x12 space will be pre-assigned to ensure show balance. We cannot guarantee shade or mother nature's moods. All spaces will be on grass. Please plan accordingly and provide your own shade and display that will be suitable for lawn. NO stakes allowed only sandbags or weights please.
- Set UP and Tear Down:** Set up is Saturday morning, August 31 between 7 - 9 am. Please do not arrive after 9 am to set up. Artists are responsible for their own set-up, terms of sales, cashiering, sales tax, delivery, insurance, and tear-down and clean up. Please do not remove or tear-down before 4 pm regardless of sales or lack of sales.
- Artwork and Crafts:** This is a juried show. All artwork and crafts must be original and of good quality. No commercial or imports are acceptable. If more than one type of work is submitted for a single booth, they will be juried separately and accepted or rejected individually by type. Preference will be given to returning artisans.
- Registration:** Each application will be judged individually by our jury committee. Returning artisans do not need to send photos unless products have changed. New artisans must provide three to five photos representative of the work they will be selling. Entries must be postmarked by June 1, 2019.

  2. Copy of Sellers Temporary Sub-Permit (if required) issued by the California State Board of Equalization. For assistance from state board of equalization during regular business hours phone 1-800-400-7115. Address on the sub-permit must show: 501 Peninsula Drive, Lake Almanor, CA 96137.
  3. New artisans - please send three to five color photos. One of booth, if available.
  4. \$65 vendor application fee payable to Lake Almanor Community Foundation (no commission charged). Notification of acceptance or non-acceptance will be emailed on or before June 15, 2019.  
If not using email, a stamped, self-addressed, long/legal size envelope for the return of your acceptance or rejection notification for this process.
