Boats registered by the state with an occupant of the rental unit may purchase boat stickers weekly or annually at the cost of \$50 per week (1-7 days) or \$250 annually (calendar year Jan-Dec). Boat stickers are required to use LACC launch and/or dock facilities. Please include the vessel and trailer information even if you do not plan on using our facilities.

LACC charges each Long-Term Renter a registration fee of \$100. RF or boat fees are separate and payable to LACC Security at Clifford Gate at the time of obtaining each item. This form and the registration fee are valid for 30 days to 12 months and must be renewed at the end of the 12 months with the Lake Almanor Country Club Administrative Office. Long Term Renters do not have the ability to have a family or "any time" list on file with the LACC Security Department. Guests or family members must be called in for each visit. Gate cards are not provided to Long Term Renters unless it is provided by the homeowner. RF tags may be provided at a charge of \$10 each to vehicles registered to a person occupying the rental unit as per the rental agreement with the homeowner. Vehicles must be present at Clifford Gate along with state registration form and owner photo ID in order for Security staff to install stickers or RF tags. Gate access for will remain valid for as long as tenancy is active for the person(s) occupying the rental unit.

I hereby recognize that all recreational facilities, the golf course and the roads within the Lake Almanor Country Club are the private property of the Lake Almanor Country Club, and are subject to regulation by the Lake Almanor Country Club. I hereby recognize that all roads in the Lake Almanor Country Club are subject to California Vehicle Code enforcement by LACC Security, Plumas County Sheriff, and or California Highway Patrol. I hereby agree to abide by all governing documents and rules for the use of these facilities, and I agree to notify each member of my household or guests, of the duty of all persons within the Club to abide by the rules of the Club. The Country Club rigorously enforces the occupancy and vehicle limits set for rental homes by the owner and renters who overcrowd their unit are subject to immediate suspension of Club privileges.
